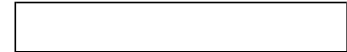

- *** ENFORCER v0001 to on hire in ANT 31/10, call SAL 7/11 and load T/S imports ex Miriam Borchard v1004, then to CAS 12/11 continuing northbound
- ** Miriam Borchard v1004 to discharge imports at SAL on 6/11 for T/S to ENFORCER v0001 on 8/11, Miriam Borchard to then turn southbound & take the position of ENFORCER v0002
- ** ENFORCER v0001 to discharge LIV, DUB and ANT exports in SAL 7/11 to be T/S onto Miriam Borchard v1005 heading southbound
- **** ENFORCER v0001 to discharge LIV and DUB exports in ANT 21/11 for T/S to Katherine Borchard v1119 returning from maintenance
- **** ENFORCER v0001 to redelivery after discharge in ANT 21/11
- ENFORCER v0001 & Sara v0433 CAS exports to East Med to load on WM vessel - Ruth v0465 (9/11)
- **** Amelie v0170 to dry dock in Antwerp 22/10 after discharge, to return in Antwerp to load exports 19/11
- Rachel v0968 to call Iskenderun 12/11 in place of Miriam v1006
